Programmes** is granted with the sanctioned intake mentioned against each, for the **academic year 2011 -12** at Theni Kamavar Sangam College of Technology, Theni Road, Koduvilarpatti, Theni – 625 534.

The above said provisional affiliation is given subject to the fulfillment of the following deficiencies as reported by the inspection committee.

- a. There is a shortage of one workshop.
- b. There is a shortage of Seminar Hall.
- c. Qualified Principal is to be appointed.
- d. Faculty members for the increase in intake are only identified; to be joined.
- e. Faculty cadre ratio is to be maintained.

In respect of programmes for which conditional provisional affiliation is granted, further inspection will be conducted, if the University deems it necessary, to verify the compliance in rectifying the deficiencies. The compliance report regarding the rectification of the deficiencies should be submitted to this office on or before **30.09.2011**.

The Provisional Affiliation is granted without prejudice to the right of the University, requiring production of the certificate required under section 37-B of Tamil Nadu Land Reforms (LC) Act 1961, subject to the decision of the Hon'ble High Court of Madras in W.A.No.3454/2002 batch and W.A.No.3482/2002 batch.

Under no circumstances, fresh admission shall be made in the above course(s) during the **academic year 2012 – 13**, until and unless the continuation for Provisional Affiliation is obtained from the University for the year 2012 - 13.

The Management should submit a duly signed undertaking on a Rs. 20/- non-judicial stamp paper to the **Vice-Chancellor, Anna University of Technology Madurai, Madurai – 625 002**, **within 15 days** from the date of receipt of this letter to the effect that the conditions specified above will be fulfilled.
